## Executive Order 2023-11, 2023-12, 2023-14

Good Afternoon,

Today Gov. Stitt issued three executive orders designed to reduce the size of government.

- [Executive Order 2023-11](#) requires state agencies to conduct a detailed review of job positions created since March 2020 and provide that list to the Secretary of Operations and Government Efficiency.
- [Executive Order 2023-12](#) states a moratorium shall remain in place on nonessential out-of-state travel for all state employees that is paid for by the State of Oklahoma and requires advance written notification for travel paid for by an entity other than the state.
- [Executive Order 2023-14](#) directs administrative heads and chief executives to take the necessary actions to insure all vehicles owned by the state and under the control of a state agency have been scheduled with OMES Fleet Management, no later than June 30, 2023, to be equipped with an automatic vehicle locator (AVL) and placed on the Fleet Management M5 System.

The filed executive orders are attached and will take effect immediately.

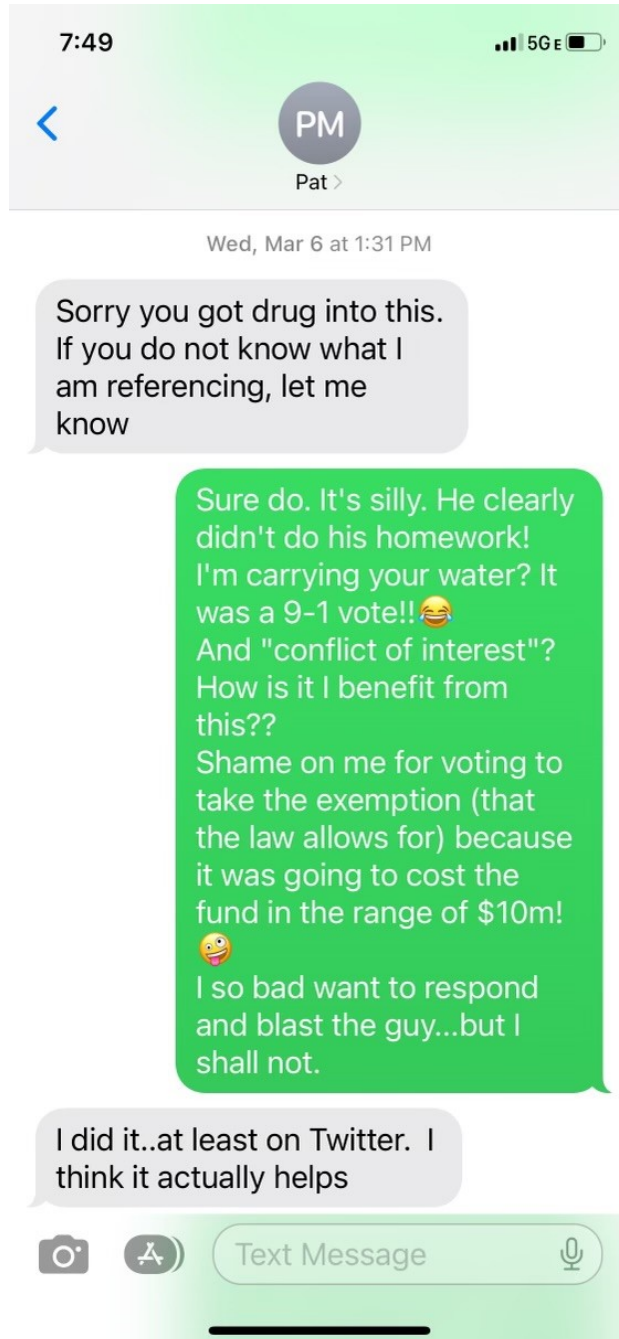
